1. Background

AMDA Nepal in collaboration with AMDA MINDS Japan has been implementing Maternal and child health project at Gadhawa Gaunpalika, Dang, Lumbini province. The project started with the aim to improve maternal and child health situation of Gadhawa Rural municipality of Dang district since March 2019. It supports strengthen and enhance service delivery by providing training to local health staff, construction of local health facilities, strengthen the management capacity of HFOMC and at community level, this project is working to increase health awareness and demand generation on MCH related issues by mobilizing health mothers groups and FCHVs.
