Terms of Reference (TOR)

1. Introduction

Association of Medical Doctors of Asia-Nepal (AMDA-Nepal) is a humanitarian, nonprofit-making, non-political, non-sectarian, Non-Governmental Organization working with its mission to promote the health and well-being of the underprivileged and marginalized people under the slogan “Better quality of life for better future”. It was established in 1989 as a chapter of AMDA-International, Japan and was officially registered in the government office as an NGO in 1990.

2. Objective

Design, Develop, deploy a fully responsive, high performance, dynamic, and template-based content management system (CMS), website for online presence of our hospitals, academic institutes, and projects. This CMS will use a modular approach to handle templates, themes, and website components for hospitals, academic institutions, and projects. The website's template-based structure ensures that when a new hospital/academic/project is added, default themes, colors, and menus are automatically applied, making expansion easier. Built on a modular framework, the platform will allow for flexible updates and smooth integration. The CMS will have dedicated sections for each hospital, allowing users to register patients online, view doctor profiles, book appointments, and access real-time hospital data. For academic institutes, there will be features like online student registration, teacher profiles, and academic information. Additionally, there will be a dedicated system for online job applications.

3. Invitation:

AMDA Nepal invites responses (“proposal”) to this Terms of Reference (“ToR”) from Software Development company (“Vendor”) for upgrade (design, development, implementation & Maintenance) of existing AMDA Nepal website (<https://amda.org.np>) described in this TOR, “Scope of Work”. AMDA reserves the right to extend the Term for a period as mentioned in this document, such extensions on the same terms and conditions, subject to AMDA obligations at law. Proposals must be received not later than the time, date and venue mentioned in the fact sheet. Proposals that are received late will not be considered in this procurement process.

4. Scope of work

AMDA Nepal is issuing this request for upgrading AMDA Nepal’s website include designing, developing, deploy and maintain a modular CMS to dynamically manage websites for hospitals, academic institutions, and projects; facilitating online patient and student registration including appointment scheduling, enabling users to view doctor profiles and book appointments. It reflects key data from hospital management information system (HMIS) and student management information systems into the websites. It shall automate the creation of websites for new hospitals, academic institutions, or projects using predefined templates and providing customizable themes for different types of websites.

The vendor shall use the latest technology MVC framework in Laravel to redesign, develop and implement the application for AMDA. AMDA may choose designing as needed. Vendors shall add at least but not limited to features as described in the ANNEX -1.

- i. Modular CMS Design
 - Enable dynamic management of websites for hospitals, academic institutions, and projects.
- ii. Online Patient and Student Registration

- Facilitate patient registration and appointment scheduling for hospitals, and student registration and record management for academic institutions. AMDA shall provide the forms.
- iii. Doctor Profiles and Appointment Booking
 - Allow users to view doctor details and book appointments online.
- iv. Hospital and Student Data Integration
 - Reflect real-time data from hospital management software (HMS) and student management systems (SIS) directly on the respective websites.
- v. Online Vacancy:
 - The Online Vacancy section on our website enables applicants to apply for job openings following the AMDA format (personal history form). The details form shall be provided by AMDA.
- vi. Automated Website Creation:
 - Automatically generate websites for new hospitals, academic institutions, or projects using predefined templates.
- vii. Responsive Design
 - Ensure optimal user experience across all devices (mobile, tablet, desktop).
- viii. Customizable Themes
 - Provide easily customizable templates for different offices.

5. Deliverables

- The vendor shall be responsible for all the development, implementation, testing, installation, maintenance, support, feature enhancements, documentation, operations and management of website and database.
- Fixes and end-user problem.
- The end user support would include all activities related to resolving the bugs / defects reported by application users. Every bug / defect should be logged and categorized on the severity levels.
- Vendors identify the solution, take necessary approvals from AMDA Nepal, and release the patch for User Acceptance Test after fixing the defects.

6. Training and support

- Training of staff in maintenance, troubleshooting and day-to-day software work would be required.
- Free support and minor customization of websites at least 3 years from delivery of software.
- The support system may site visit/phone call / remote login/ group chat.
- Any written requirement or customization in software should be solved at the earliest possible or within 2 weeks.

7. Report

Generation of reports from the database would be required for which a comprehensive and customized report module would have to be developed with option for users to choose different data fields with sorting and filtering option for generating different outputs based upon fields selected.

8. Term and Condition

- Handover the copyright of the website and application to AMDA Nepal.
- Do not put any kind of business advertisement on the website, without the explicit written approval of AMDA Nepal.

- Confirm to the technical and quality standard.

9. Invoicing and Payment

- AMDA shall pay the vendor the price for the service within 30 days of installation of the website.
- The vendor shall issue the invoice to the name as indicated in the purchase order.
- Payment will be made from A/C payee bank Cheque.

10. Schedule

- The date for service completion shall be 60 days after signing the agreement and/or as mentioned in the date of purchase order issued.
- The vendor shall forthwith give notice to AMDA of any likely delay in service of which it becomes aware of and shall provide AMDA with prompt and reasonable notice of the re-scheduled service date.
- If vendor is late with complete delivery of ordered service, AMDA Nepal shall have the right to cancel the order for such service at any time before completion of service.
- AMDA Nepal reserves the right to reject the unspecified services. In the case the vendor fails to provide the ordered service within the deadline, AMDA reserves the right to forfeit the outstanding payment and/or the bank guarantee and can cease the agreement with immediate effect.

ANNEX -1

(Features to be added by vendor in the existing website of AMDA Nepal)

Features/Services

A. Standard features and services

1. Dashboard

- Enhanced dashboard with Summary information, quick information, remainder etc. including the number of applicants applied for the opening vacancies, number of online patients' registration.

2. Responsive and Accessible design

- Mobile-First Design: The CMS will ensure that all websites are fully responsive, providing an optimal experience on mobile, tablet, and desktop devices.
- Ensure consistent performance across major browsers (Chrome, Edge, Firefox, Safari) and operating systems.
- Website hosted on https and/or http.
- Lazy loading of pages to reduce the initial load time.
- Able to create duplicate pages.

3. Modular CMS for Website Management

- i. Custom Templates:
 - Hospital Websites: Include features for doctor profiles, online appointment scheduling, and online patient registration.
 - Academic Websites: Focus on academic programs, faculty details, online student registration, and integration with the student management system.
 - Project Websites: Highlight project details, timelines, goals, and achievements.
- ii. Themes and Reusable Element
 - Consistent themes across websites with customizable color schemes, logos, and layouts.

4. Online Patient Registration and Doctor Appointment Booking

- i. Doctor Profiles:
 - Each hospital website will display doctor names in a directory, allowing users to click on a doctor's name to view their full profile (qualifications, specialties, availability).
 - Online Appointment: After viewing a doctor's profile, patients can book appointments online by selecting their preferred date and time. The system will be integrated with the hospital's appointment scheduling system to reflect real-time availability.
- ii. Online Patient Registration:
 - Patients can register on the hospital website by filling out personal information. The patient record shall be tracked and presented as required.
 - Integration with the hospital management software (HMS) will ensure patient data is securely stored and available for future appointments and medical history access.

5. Online Student Registration and Record Management

- i. Online Student Registration:
 - Academic websites will allow prospective students to register online, submit required documents, and apply for courses.
 - Integration with the student information system (SIS) will manage the admissions process, track applications, and notify students of their registration status.
- ii. Student Data Display:

- The CMS will reflect data from the student management system, such as student records, academic achievements, and course enrollments. This feature will enable real-time updates of student profiles and academic information on the website.

6. Integration with Hospital and Student Management Systems

- Hospital Management System Integration:
 - Display Real-Time Data: The hospital website will reflect real-time data from the HMIS, including the number of patients (inpatients and outpatients), lab reports, and indoor patient data.
 - Patient Statistics Dashboard: A dashboard displaying daily patient statistics, lab test results, and overall hospital performance can be integrated into the hospital website, providing useful information to administrators and visitors.
- Student Management System Integration:
 - Academic websites will integrate with the SIS to reflect real-time student data, such as enrolled courses, and academic progress.

7. Online Vacancy Module

- The Online Vacancy on the website is designed to streamline the job application process, making it easy for both applicants and HR. This section allows candidates to apply directly through our site by filling out an online form with personal, professional details and supporting documents.
- It will ensure that HR has easy access to well-organized candidate profiles, improving their ability to quickly identify suitable applicants for opening positions.
- Online job applications will be modified with steps enhancing with user friendly. In addition, automatically short listing of applicants from the system on given criteria by AMDA.
- Modify according to organization need.

8. Automated Website Generation for New Entities

- Default Template Assignment:
 - When a new hospital, academic institution, or project is added, the CMS will automatically generate a fully functional website using predefined templates tailored to the specific type of entity.
- Customizable Setup:
 - Once generated, administrators can easily customize the website by adding specific content, such as doctor profiles, hospital services, or academic programs.
- Scalability:
 - The system will allow for seamless scalability, enabling the NGO to add multiple hospitals, academic institutions, or projects without requiring additional development.

9. Branch Setup:

- Allow to create duplicate branch (duplicate all page) by super admin.
- Allow to archive branches that are hidden by super admin.
- Allow to add start and expiry date of pages.
- Data sync and/ entry from/with hospitals, college and projects.

10. Role Based Access Control:

- Super admin role will be added. Super admin will have full privilege to CRUD operation for all branches.
- Super admin can change the user's branch and can set up which users are allowed to see which pages of website.

- Main site users will access all Media library, but branch users will access only its own media library.
- User role: Super admin, branch admin, user.
- News, notice and report shall be created, reviewed and published.
- Super admin will manage global settings (themes, templates, etc.), ensuring uniformity across websites.
- Hospitals, academic institutions, and project teams will have the flexibility to manage their local content, such as updates to doctor profiles, student records, or project activities.

11. Deployment of website:

- The vendor will be responsible for hosting and maintaining the website on cPanel, the website may be deployed offline too to utilize the modular feature of website.

12. Offline Deployment:

- Support to run offline (local server) computer.

13. News/Events/Notice board /popup add

- Latest News and Notice will be displayed and can be controlled by settings.
- Allow the publisher to edit the content and then publish (in all news/notice/report)
- Multiple popup images or files. In addition, we will accept upload images/files and/or link URL (cloud storage).

14. Reporting

- Integrated with Nepali and English date/calendar
- Report can be exported to excel and pdf format.
- The reports can be filtered by date, name etc.
- Hospital, academic and project data with indicators will be displayed (as per data input separate form) on the main page of site of hospitals and project separately.
- The required reports shall be generated as required.

15. Search:

- This model helps users to search for desired information instantly.
- Add search features as needed by organization.
- Search by keyword, indexing, by date, name.

16. Photo & Video:

- Able to link and fetch from cloud storage.
- Changeable size and position of front and back page.
- Photo/video resizing, zoom in/out.

17. Social media plugin and interfaces:

- Allow integration of feeds from the social websites like Facebook, twitter(X), Instagram, WhatsApp etc. to allow sharing of the content for maximum integration on the websites blogs/blog pages.
- Facebook, twitter(X), Instagram, WhatsApp etc. sections separately will be added.

18. Archive Section:

- As appropriate, old articles should be moved to the archive.
- All operations like searches and views should be available for archived information as well.

19. Security and Performance

- SSL Encryption: All websites will be secured using SSL certificates, ensuring safe data transmission for patient registrations, student records, and appointment bookings.

20. Search Engine Optimization

- SEO-Friendly Features: Each website will be optimized with clean URLs, metadata, and automatic sitemap generation to improve search engine rankings.

- ii. Meta Tags and Descriptions: Customizable meta descriptions for individual entities to enhance their visibility in search engine results.
