B. Narrative Summary of Activities and Key Findings

1. Details on Screening Camp

The activities undertaken in the camp have been listed in the points below in a sequential manner.

- Registration of clients was undertaken.
- Written informed consent was taken from the clients in the consent form.
- Breast and Cervical Cancer Screening Forms were filled which included personal details, medical history, family history and detail on procedure conducted and findings.
- Blood pressure and height of the clients were measured and recorded.
- Cervical cancer screening was performed through visual inspection of the cervix with acetic acid (VIA).
- After the cervical cancer screening, clinical examination of breast was performed for breast cancer screening.
- The findings from both the cervical and breast cancer screening was disseminated by the medical team with necessary health information and counseling.
- Those women who were screened positive (VIA positive and suspected lump in the breast) in the screening tests were referred to the Teaching Hospital for confirmatory diagnosis and prompt treatment.

a) Screening Camp at AMDA Clinic

This was a one day event conducted on 19th February (5th Falgun 2078) at AMDA Clinic, Ward no 6. The camp was executed from 9.00 am to 3:00 pm. A total of 10 team members, comprising of doctors, nursing staffs, clinic aid, and project staffs (see section 1.1, complete list of team members), 2 trained staff of Jorpati Health Post (JHP) and 5 FCHV of JHP were mobilized for the camp administration and service delivery. The Chief Administrator of Gokarneshwore Municipality had arrived for the supervision of the screening camp at the clinic. The event was targeted to women between 30 to 60 years of age. A total of 65 women attended the camp and among them 52 clients benefitted from cervical cancer screening services and 65 clients benefited from breast cancer screening service.

b) Screening Camp at Gamcha Community Health Center, Gamcha

This was a one day event conducted on 26th February 2022 (12th Falgun 2078) Gamcha Community Health Center(CHC) at Ward- 3. This CHC comes under the Baluwa Health Post The camp was executed from 9.00 am to 3:00 pm. A total of 12 team members comprising of doctors, nursing staffs, clinic aid, and project staffs (see section 1.1, complete list of team members)were mobilized for the camp administration and service delivery. There was a supervision visit by Chief Administrator, Section Officer, Finance Officer and Health desk Team (HDT) of Gokarneswore Nagarpalika. In this camp, 2 trained Staff, 5 FCHV along with the support of Baluwa HP Incharge the camp was conducted in a well managed manner. The event was targeted to women between 30 to 60 years of age. A total of 67 women attended the camp and 62 clients benefitted from cervical cancer screening services and 65 clients benefited from breast cancer screening services.

This has aided in demand generation activities and client flow management during screening camp day.

Through this educational activities, we are able to reach to the community women and was aware on Breast and Cervical Cancer Screening Services. Also emphasized the imperative aspects of screening on healthy person and need to bring positive change on their health seeking behaviors of women instead of being shy and hesitated. Ultimately, it had promoted the women health and that lead to happy and healthyi life of women and family too.

4. Coordination Meeting

On 21st February, we had coordination meeting with women focal person of Ward Member, FCHV and Health Post Incharge of Baluwa. On the day, we discussed regarding need of screening camp at Gamcha Community, also ensured whether any camp had conducted or not. We finalized the date of educational activities among womens group. Likewise, on the same day, we had meeting with Health Facility In-charge and Health Desk Team at Gokarna Primary Hospital. We discussed and finalized the camp schedule and educational activities at the respective sites for the upcoming month. Also, had discussion on follow up of the positive cases and concluded with the preparation on the list of positive clients and circular that to respective health facilities(HF) for further follow-up. This meeting was quite productive for the liaison with the HF Incharge and Health Desk team of Gokarna Municipality.

5. Annual Review Meeting

On 4th February 2022, we had Annual Review Meeting-Internal within the team at AMDA office where program officer shared all the achievement, progress report and challenges faced within this year. Discussed on the areas that need to be addressed with the rational and also in the follow up of the clients of VIA positive. Concluded with few amendments and need of immediate action on referral linakge.

On 20th February 2022, Annual Review Meeting was conducted at Gokarna Forest Resort in the presence of Mayor and Deputy Mayor of Gokarneshwore Municipality(GM), Chief Administrator, Section Officer and Health Desk Team and Health Facility Incharge of Gokarneswore Municipality. Likewise, President, Chief Administrator, Consultant and all the team of AMDA Office along with

Program Officer from District Health office(DHO) and the Medical Director and Oncologist of Nepal Medical College and representative of AMDA-Minds was also present in the meeting.

The program was conducted smoothly as per the planned program schedule. With the warm welcome, program officer presented in detail regarding program objective, activities, progress report, service report i.e complied report and health facility wise report, achievement, success story and challenges faced during an entire year. Also, shared the year 2 Program Planning along with the set targets. Likewise, Dr. YP Singh, Consultant and Health Post In-charge of Sundarijal shared their experiences regarding this program. After that, we had a feedback session from all the delegated and shared the solution for the major challenges i.e. referral linkage for the suspected clients. For which, MD of NMC was eager to work jointly along with the GM and AMDA Nepal. At the end of the program, closing remarks was given by DHO and AMDA Minds with their valuable suggestion and appreciation regarding the program. The program was ended with the vote of thanks by President of AMDA.

6. Lesson Learned

Before finalization of the Camp Site we need to reconfirm whether any event or similar camp had been conducted on the same site or not. At Tareeveer Urban Clinic, Gynae Camp was conducted at around 8 month back due to which we had to post pond the Screening Camp at Tareeveer Urban Clinic on 16th April 2022 (tentative date).

7. Success Story

Educational Activities

Educational Activities had always played the pivotal role in our approach to improve access to screening services. It had educated the women regarding need of regular checkup inspite of presence of any medical problems. Also, screening is done to healthy person to rule out the health status of person and promote the well-being.

Unlike the regular women's group, we were able to conduct educational activities among the beautician. Two groups of beautician i.e Rupa's Beauty Parlour, Makalbari and Sunaura Beauty Studio, Boudha jointly gathered at Rupa's Beauty Parlour. The group was quite different than the regular one as this women were educated, active and health conscious. However, they were unaware regarding importance of regular cancer screening checkup. With the active participation and interactive lecture we were able to disseminate the information regarding breast and cervical cancer screening services. Ultimately, the program brought positive changes regarding their concept on screening services and also, emphasized on need of health seeking behavior and practices.







Krishna Maya Nagarkoti, 47 years old lady who is the member of women's group of Gamcha, stated that this is her first check up at the age of 47. Due to shyness and hesitation, she never went for the check-up neither during her delivery time. She was so glad to receive service at Gamcha Community Health Center and was thankful to conduct the awareness program through which she was able to understand the importance of screening services, otherwise she would never be ready for the service. Also, being the member of women's group, she is going to disseminate the information regarding breast and cervical cancer screening services to the women in her community as this both are the preventable if we do regular screening and be saved from the fatal disease.
