### • Sunsari:

Conducted creative event (PrEP focused) on 21<sup>st</sup> November, 2024 in Itahari City clinic. A total of 12 KPs participated in the event. It was facilitated by Case manager, DIC Operator and CBS. There was discussion on importance of PrEP and its continuation. They are also taught about mental health, mediums of HIV transmission and ways to prevent it. Through the event 1 FSW (1.2) started PrEP,5 PrEP refill (1.2=3, 1.3=2), 7 HIV Screening, 4 STI Screening of which 2 were diagnosed for STI and 3 of them were treated.

### Morang

Conducted creative event (PrEP focused) on 20<sup>th</sup> November, 2024 in Itahari city clinic. All the participants were called in Itahari city clinic according to their feasibility. A total of 12 FSWs participated in the event facilitated by CBS, PN and Case Manager. The discussion was mainly focused on importance of PrEP Along with that HIV related preventive measures were also discussed in the meeting.

### • Jhapa

Conducted creative event (PrEP focused) on 22<sup>th</sup>Novemberin Birtamod City clinic. A total of 20 FSWs (1.2-3, 1.3-17) were participated in the event which was facilitated by HA, DIC,

**Monthly Update: November 2024** 

CBS & P.N. Discussion was done about the importance of PrEP its advantages, sexually transmitted Infections (STIs) and its effects. In this event, 112 KP tested for HIV & STI and 7 KP started PrEP, 3 KP restarted PrEP, 2 KP refill Also 8 KPs was diagnosed and 1 treated for Sexually Transmitted Infections (STIs).

### **Stigma and Discrimination Reduction Training:**

#### • Ilam

Conducted HIV related stigma and discrimination reduction training on 25<sup>th</sup> November, 2024 at Ilam Municipality-6, District Prison (Karagar) Ilam. In the orientation there was presence of 42 participants among them 38 male and 3 were female. The program was conducted by HIV Prevention officer, HA-ART, PN from AMDA Nepal. The participants of the program were prison, police. The program was interactive and discussion was done about different aspects of HIV, AIDS and stigma & discrimination. Further, we offered for HIV testing if had risk behavior to those participants who were interested to know their HIV status.

### Morang

Conducted HIV related stigma and discrimination reduction orientation on 26<sup>th</sup> November, 2024 at Sundar Haraicha Morang to Asian highway workers. In the orientation there was presence of 38 participants among them 34 male and 4 were female. The program was conducted by Program/M&E Specialist, Sr. Lab Assistant and CBS plus from AMDA Nepal. There was sharing of current situation of HIV/AIDS, its basic concept, mode of transmission, clinical features, treatment, preventive measures and causes of stigma and discrimination to PLHIV in the community and role of each individual to minimize the HIV related stigma in the community. Further, we offered for HIV testing if had risk behavior to those participants who were interested to know their HIV status.

### Viral Load campaign

• In Morang district total of 24 viral load sample collection was done on November, 2024i n coordination with ART Center and BDS sub-IPs and send to Koshi Zonal Hospital.

- In Sunsari a total of 15 viral load sample collection was done on November in coordination with ART Center and BDS sub-IPs and send to Koshi Zonal Hospital.
- In Jhapa a total of 23 viral load sample collection was done on November in coordination with ART Center and BDS sub-IPs and send to Koshi Zonal Hospital.
- In Ilam a total of 12 viral load sample collection was done on November in coordination with ART Center and send to Koshi Zonal Hospital.
